- Copy of Tribal ID
- Completed fingerprint card
- Certificates of Good Standing from all other jurisdictions (if applicable)
- Payment of \$25.00 Application fee

REQUIREMENTS FOR ADMISSION AS AN ADVOCATE (from CLOC Art. II, Ch. 6 § 2):

Lay Advocates. A lay advocate is a member of the Cocopah Indian Tribe or another federally recognized tribe. A lay advocate is not an attorney and may be admitted to practice before the courts of the Cocopah Indian Tribe so long as the advocate:

- a. Completes and files an application approved by the Chief Judge of the Cocopah Indian Tribal Court, submitting proof of good standing from all tribal courts to which said applicant has been admitted to practice;
- b. Has not been convicted in any court (i) of a misdemeanor within the last seven (7) years prior to application or (ii) of a felony;
- c. Certifies that he or she has read and understood these Rules in their entirety;
- d. Earns a passing score on the bar examination administered by the Chief Judge of the Cocopah Indian Tribal Court; and
- e. Appears before the Tribal Court and makes oath to uphold all Cocopah Indian tribal laws, ordinances, rules of courts and procedures.
- f. Has not been disbarred by any jurisdiction;
- g. Is not under suspension from the practice of law by any jurisdiction;

Misstatements on Admission. In connection with a person's application for admission to the tribal bar, such person shall not make any statement which the person knows or should know is false and misleading, nor shall the person fail to disclose any fact or information which the person knows or should know is material to such application.

ADMISSION AS AN ADVOCATE

First, you must submit your completed Application and all required documents. If your Application is provisionally approved, your fingerprint card will be sent to law enforcement to complete your background check. If your application is provisionally approved, you may obtain a copy of the Cocopah Law and Order Code from the Clerk of Court.

If your background check is acceptable, the Clerk of Court will contact you to schedule a time for you to take the Cocopah Bar Exam.

If you earn a passing score on the Cocopah Bar Exam, the Clerk of Court will contact you to schedule a time for you to appear before this Court to be sworn in as an Advocate.
