- You must have some knowledge of your culture, history, values, traditions and issues of your tribe.
- You must be currently attending high school, college or vocation school and plan to continue your education toward obtaining a degree.
- You must be willing and able to communicate with the public.
- You must comply with all program requirements, rules and regulations.
- You must participate in all program activities
